17. <u>Instructions for Applying for Membership.</u>

- a. Membership is for the specific Sports Complex, only.
- b. Senior citizen, Spec children / U/7 free of charges, registration is mandatory.
- c. DHA employee and family (grade 17 and above) free of charges, registration is mandatory.
- d. DHA employee children (grade 16 and below) free of charges, registration is mandatory.

- e. Sports gears will be players own resp.
- f. Separate membership for joining club / coaching will be required, 15% discount permitted on monthly subs, only to 3 family members joining any club together.
- g. Annual inc to be included in charges / subscription or as decided by DHA management. Coaching Camp rates / Academy rates, will be revised as and when req. MS card charges will be as actual.
- j. DHA has the right to cancel the registration on violation of its sports standing operating procedures or bye laws, w/o assigning any reason.
- k. Max of three guests permitted in a month (Foreigner may enter but on foreigner membership).
- 1 Maids are allowed entry, on obtaining the registration fee (will sit in the waiting area only).

18. Freeze / Defreeze Cases Policy Sports Complexes / S – Pool Complex

- a. All sports complexes will receive request from the members at least 10 days in advance.
- b. Complex members will pay 15% as freeze charges of the monthly subscriptions. They will not be permitted to enter the complex till defreezing of membership.
- c. Membership stands frozen, if the member fails to pay charges /monthly subscriptions for consecutive two months w/o giving application for freezing of membership. After two months, 50% charges for absentee period will be paid, to defreeze the Membership.
- d. In the event of nonpayment of charges / subscription for six months by the members, the membership will be cancelled. New registration will be required besides paying 50% of the balance monthly subscription of absentee months. However on medical reasons by production of medical documents only 15% of the pending monthly subscription membership will be restored.
- 19. **Freezing Policy for DHA Clubs and Academies** Clubs MS can be frozen for a period of at least one month or more with following conditions.
 - Member should request for freezing Membership on an application 10 days in advance. No freeze charges will be levied.
 - b. If a member doesn't pay monthly subscriptions for consecutive two months then on his rejoining he will have to pay 5% of the subscriptions for the absentee period.
